Economic Development Partnership Award

NENEDD recognizes the Nebraska Department of Economic Development (NDED) as the recipient of the Economic Development Partnership Award. NDED is the lead economic development agency for Nebraska emphasizing growing and diversifying the state's economic base, and bringing new dollars into the state. Their mission is: "To provide quality leadership and services that enable Nebraska communities, businesses, and people to succeed in a global economy."

One of NDED's major programs, which is specific to our local government members, is the Community Development Block Grant (CDBG) program, which has played a major role in a variety of projects across our region. During the past 10 years NDED has made over \$29 million of investments in the following categories (at right) in northeast Nebraska which created/retained 880 jobs and assisted 192 housing units.

 - ▲ \$2,512,662 CDBG Disaster Funding for planning, flood control, drainage, lift station replacement, cleanup
 - ▲ \$2,580,650 CDBG Downtown Revitalization for community planning, street improvements, façade improvements
 - ▲ \$6,945,665 CDBG Economic Development for direct financing to business which created/retained 872 jobs
 - ▲ \$2,196,000 CDBG Housing for owner-occupied housing rehabilitation and down payment assistance
 - ▲ \$810,000 CDBG Planning for Comprehensive plans, preliminary engineering reports, housing studies, recreation & wellness master planning, water systems, utility mapping, industrial park planning
 - ▲ \$6,668,065 CDBG Public Works for streets, sidewalks, Libraries, Fire Halls, Fire equipment, ADA improvements, Community and Senior Centers
 - ▲ \$337,500 CDBG Tourism for Nissen Wine Outlaw Trail Historic Center and Columbus Museum, Inc.
 - ▲ \$2,103,400 CDBG Water/Wastewater for flood control and drainage, water/sewer treatment facilities, lagoons and lift stations

Without the continued partnership that NENEDD and its community members have with NDED these projects may not have come to pass. NDED has an open door policy and is always willing to sit down and discuss projects and workable solutions to insure that projects are successful. In addition to the CDBG program NDED also has funds through the Nebraska Affordable Housing Trust Fund and the HOME Investment Partnership Program. These two programs alone have resulted in over \$10.6 million of investment into northeast Nebraska and assisted 343 housing units.

NENEDD honored the City of Schuyler as the recipient of the Doug Bereuter Accomplished Community Award.

Schuyler has been very proactive in their planning efforts for future growth. In the last ten years the City has received numerous grants for various projects totaling over \$3 million. Schuyler has received three Community Development Block Grant (CDBG) Comprehensive Investment Stabilization (CIS) grants. The CIS grants have aided in outlining

potential projects and improving the City's infrastructure. The City has also replaced their lift station in 2009 and improved storm sewers in 2010 with CDBG disaster funds. Most recently, the City received CDBG and Nebraska Investment Finance Authority (NIFA) funding to assist in updating their Comprehensive Plan that will include a citywide housing study. In the last decade, NENEDD has assisted 13 Schuyler businesses in obtaining over \$800,000 in business loans which created or retained 45 jobs.

In addition to the City's efforts, Schuyler Community Development (SCD) holds Downtown Revitalization & Commercial Development Committee (DRCDC) committee meetings once a month in order to maintain and improve the downtown. Schuyler is currently in the process of having the downtown designated as a historical district. SCD also holds monthly meetings that focus on housing in Schuyler.
